AmeriBar Pass Guarantee Program Agreement

This is AmeriBar's Pass Guarantee Program Agreement (Agreement). All representation and agreements between you (Student) and us (AmeriBar) are contained in this Agreement and the Program's Affidavit. By signing this Agreement, Student represents that Student:

1. Has never taken any bar exam;
2. Has graduated or will graduate from an ABA fully accredited law school located within the fifty (50) states of the United States or the District of Columbia;
3. Will take the bar exam within six (6) months of law school graduation; and
4. Agrees to comply with all terms and conditions set forth herein.

Terms and Conditions

Student hereby agrees to the following terms and conditions:

- A. Student shall complete each and every task assigned by AmeriBar by deadline without exception. Failure to meet any deadline disqualifies Student from the money back guarantee;
- B. Student shall complete and timely submit a completed study calendar/plan in the format provided by AmeriBar;
- C. Student shall complete and timely submit two (2) outline writing skills tests administered by AmeriBar;
- D. Student shall complete and timely submit two (2) 100-question online MBE exams administered by AmeriBar;
- E. Student shall complete and timely submit eight (8) essays administered and critiqued by AmeriBar;
- F. Student shall complete at least one thousand (1,000) online MBE questions;
- G. Student shall study for the bar exam for at least (300) hours;
- H. Student shall outline every subject covered in AmeriBar's materials provided to Student and promptly submit all outlines selected by AmeriBar for review;
- I. Student shall listen to all strategy and substantive law lectures provided by AmeriBar using its online system and shall, upon request, submit a list of verification codes to AmeriBar within 48 hours of completing each lecture;
- J. Student shall submit, within ten (10) business days after the administration of the bar exam, AmeriBar's Affidavit of Full Compliance with these terms and conditions;
- K. Should Student fail the bar exam, Student shall provide AmeriBar with an official copy of Student's law school transcript within (30) days of being notified of the bar exam results by the bar examiners;
- L. Student shall return AmeriBar's iPod within ten (10) days of the final day of the administration of the bar examination or Student hereby agrees that AmeriBar shall charge or bill and the Student agrees to pay ninety nine dollars and no cents (\$99.00) for the iPod; and

M. Should Student fail the bar exam, Student shall return all books at Student's expense to AmeriBar within ten (10) business days of the date of the bar examiner's letter notifying the Student of the bar exam results.

AmeriBar hereby agrees to the following terms and conditions:

- A. AmeriBar shall review Student's completed study calendar/plan and provide the Student with corrective feedback if necessary;
- B. AmeriBar shall administer and review Student's two (2) outline writing skills tests and provide the Student with corrective feedback if necessary;
- C. AmeriBar shall administer and review Student's two (2) 100-question MBE exams and provide the Student with corrective feedback if necessary;
- D. AmeriBar shall review and provide written feedback for Student's eight (8) essays when submitted according to schedule;
- E. AmeriBar shall provide Student with a complete bar review course and all appropriate lectures on an iPod upon Student signing, dating, and returning this agreement to AmeriBar within the required time period.
- F. If the Student signs, dates, completes and complies with all terms of this Agreement and truthfully complies with all conditions set forth in the supplied Affidavit of Full Compliance with the Terms and Conditions of AmeriBar's Pass Guarantee Program and Student does not pass the bar exam, then AmeriBar shall provide Student with a refund of the Student's course purchase price within 30 days of receiving all required documentation. Alternatively, Student may elect to retake the course and be provided with six telephone tutoring sessions rather than receive a refund of Student's purchase price (all valued at over \$3000);

If you follow our Pass Guarantee Program and fully comply with the above stated terms and conditions and do not pass the bar exam we will refund your purchase price or you can retake the program for free and be provided with six telephone tutoring sessions. If you elect to retake the program for free, this guarantee will no longer apply. Any failure to follow these terms and conditions voids this Agreement and Student forfeits all rights under the Pass Guarantee Program. Under no circumstances shall AmeriBar be responsible to Student for any amount in excess of Student's purchase price of AmeriBar's course.
